### Carers (Recognition and Services) Act 1995

- The right to request an assessment at the time when the cared for person is being assessed
- Assessment of the carer's ability to provide care and to sustain the caring role
- Results of assessment taken into consideration when deciding what services to provide for the cared for person
- Applies to carers of all ages

### Carers and Disabled Children Act 2000

- Applies to carers over 16 and those with parental responsibility for disabled children
- Maintaining carers health and wellbeing
- Independent assessment
- Provision of services
- Direct payments (including 16 + 17 yr olds)
- Voucher schemes
- Powers to charge for services

### The Carers (Equal Opportunities) Act 2004

### Duty to inform



- Local authorities must inform carers that they may be entitled to an assessment by:
  - Developing an information strategy
  - Targeting 'hidden carers'

## Carers assessment

Must now include consideration of the carer's needs and wishes with regard to:

- Work



- Education and training



- Leisure

## Co-operation between authorities

- The local authority can now request assistance from another public body (health, housing, education) in planning services for carers.
- Other authorities must give 'due consideration' to such requests
