# 1 About our business plan

## 1.1 Why we have a business plan

This document lays out the plan of business for the Social Care Institute for Excellence (SCIE) for the period 2006/07. It is closely linked with SCIE's corporate plan for 2006–09 which sets out SCIE's vision and strategic objectives for the years ahead and puts our work in the context of national policy developments in England, Wales and Northern Ireland. Using the corporate plan as our basis, the business plan details the specific projects we will undertake – that is, the products we will produce and the activities we will carry out – to meet our corporate objectives.

SCIE produces a business plan annually.

## 1.2 How SCIE determines our work projects

The projects included in our business plan have been determined using the following criteria:

- The project is directly related to one or more of our corporate objectives.
- The topic of the project is well-defined and topical, with a critical body of knowledge to examine.
- Similar work, as far as we know, is not being done elsewhere and/or is unlikely to be supported or undertaken by another organisation.
- The project will be useful for practice and service development.
- SCIE's stakeholders and sponsors support the project.
- The programme will achieve an equitable balance across all user groups.

SCIE's corporate objectives for 2006–09, on which our projects are focused, have been determined by our trustees, our staff and our stakeholders, looking at our achievements so far, lessons learnt from our early years and the future direction of social care.



## 2 About us

### 2.1 Our mission

SCIE's mission is to produce good practice guidance for the social care sector to improve services for the people who use them.

To achieve this mission, we have divided our programme of work into the following key areas:

- **Adults' services.** This work area is about producing good practice guides that cover the spectrum of services to adults.
- **Children and families' services.** This work area is about producing good practice guides that cover the spectrum of services to children and families.
- **E-learning.** This work area centres on the use of information and communication technologies, including the internet and World Wide Web, to improve and support teaching, training and learning.
- **Knowledge management** This programme of work focuses on improving the dissemination and availability of web-based knowledge and information for people working in and using social care.
- **People management.** This area of work is about good management practice and provides resources which can be used by employers throughout the sector.
- **Social work education.** This programme of work is about ensuring that tomorrow's social workers are highly skilled and prepared for the challenges they will face through the development of resources for social work education programmes.
- **Stakeholder participation.** This is about making sure we are engaging the full range of social care's stakeholders in developing our work programme and our products. It is also about developing resources for good practice in the involvement of service users and carers.
- **Using knowledge to support social care.** This is about deciding what information we should use as the basis for our good practice guidance, gathering and analysing that knowledge and developing a nationally agreed agenda on the areas of social care that need focused and sustained research interest.

We believe that through continuous and progressive work across these themes, we will contribute to the provision of excellent services for the people who use them.



## 2.2 Our uniqueness

SCIE is unique. We are a central source of authoritative and reliable knowledge for the whole of the social care sector. Our guidance is gathered through a range of sources – organisations, practitioners, the policy community, research and service users and carers. We do not focus solely on developing knowledge-based guidance; we also work with people to translate this guidance into practice. In turn, this improved practice yields new information, which we use to update our knowledge and practice findings.

SCIE works across children's and adults' services to ensure joined-up working for families and continuity of service from children's to adults' services.

Our resources are authoritative, knowledge-based, user friendly and freely available to all.

## 2.3 Our values

The following values underpin every aspect of SCIE's work. We promise to:

- have a service user focus
- be independent in our research and findings
- promote empowerment and change
- be committed to equality and diversity
- be transparent
- be accessible in all our work
- be accountable to our stakeholders.

To demonstrate our commitment to these values and to ensure they are reflected in all aspects of our work we will incorporate these values in:

- our approach to all the guides and resources we create or commission
- our dealings with everyone we work with
- our work to influence policy and change practice
- recruitment, management and staff support systems.

## 2.4 Our approach

SCIE's approach is collaborative. We work in consultation with those who can provide specialist expertise on projects, we work jointly with those with whom we share a common interest and we work in partnership with others when developing a common product. Our participation strategy aims to ensure that service users and carers and all other SCIE stakeholders are able to contribute meaningfully to our work.

## 2.5 Our products

SCIE produces a range of products, each of which has a different purpose. You can use these descriptions to help you understand the projects for 2006/07 listed further in this document.

### Knowledge reviews

Knowledge reviews pull together knowledge from service users, research and practice. They describe the knowledge that is available, highlight the evidence that has emerged and draw practice points from the evidence. Knowledge reviews are available both in hard copy and online.

### Position papers


Position papers present a summary of a particular policy question, for example whether service user involvement has made a difference to social care services. They identify issues and key messages and are available both in hard copy and online.

### Practice guides

Practice guides are free online resources which bring together information, research and current good practice about particular areas of social care. The guides give readers the opportunity to develop their own knowledge about what works well and apply it effectively in their day-to-day work.

### Resource guides

Resource guides direct people to information about a particular area of social care, especially where there is a lot of information and it hard to know what information to use, or where there is a new area of social care or significant changes (such as in social work education) that people need to know about. Resource guides are available both in hard copy and online.



## Reports

SCIE produces reports from time to time about various areas of social care. SCIE's reports are available both in hard copy and online.

## Research briefings

Research briefings summarise information on a particular topic. They are concise documents designed to act as a 'launch pad' or signpost to more in-depth material.

## Other resources

We also produce other resources, such as training packs, consultation documents and information booklets.

### 3 Work programme for 2006/07

The projects SCIE will undertake in 2006/07 are grouped under our key themes of work. Also listed under these themes are the support activities which we will undertake to help achieve our objectives.

For each project we have indicated which of our corporate objectives the project will help us to meet.

Our corporate objectives for 2006–09 (taken from our corporate plan) are:


1. Contribute to better outcomes for users of adults' and children's services and their carers by identifying good practice and helping to embed it in everyday social care service provision.
2. Involve all stakeholders in our work and be recognised as a resource for those stakeholders.
3. Enhance the skills base and professional confidence of the social care workforce through our resources and practice development.
4. Act as a voice for social care in the UK and be a resource for government.
5. Address gaps and inadequacies in service provision for black and minority ethnic groups and 'seldom-heard'<sup>+</sup> groups.

<sup>+</sup> SCIE prefers to use the term 'seldom-heard' rather than 'hard-to-reach'. The term 'hard-to-reach' can be taken to imply that individuals are, of their own volition, difficult to engage, rather than that their disengagement is a result of agencies' failures to proactively seek out their inclusion. Also, many people in the disability and service user movements favour the term 'seldom heard'.

### 3.1 Adults' services


SCIE's work on adults' services focuses on promoting practice and services that enhance or maintain independence and life opportunities for adult service users. It looks at barriers to independence and life opportunities – for example, slow adoption of new ways of working and variability in the quality of existing mainstream services – and seeks to address these barriers through the provision of materials to support good practice.





### 3.2 Children and families' services


SCIE's work on children and families' services focuses on family support, safeguarding children and looked-after children. It looks at effective interventions, managing the boundaries between children and families' and adults' services, organisational learning and risk management and seeks to address these barriers through the provision of materials to support good practice.

The following projects are well advanced or build on existing projects and will continue to be worked on in 2006/07 (many were begun in 2005/06). We expect that many will be completed and published during this time. Projects commencing in 2006/07 are highlighted as new.



### 3.3 E-learning

Work in this theme aims to maximise the potential of ICT to enhance workforce development in social care. The work focuses on:


- working with higher education institutions to develop e-learning materials for the social work degree
- working on the infrastructure necessary for the use of ICT in training and workforce development in social care
- the investigation of opportunities to improve the skills of the social care workforce through work-based learning
- the development of SCIE products (practice and resource guides) to provide e-learning materials.

### 3.4 Knowledge management

This theme focuses on maximising the potential of web-based resources to increase the availability of knowledge and information for people working in and using social care. This will be achieved by the continuing enhancement of the resources provided on Social Care Online and through partnerships with other organisations, either to assist with the development of their websites or to provide access to knowledge and information within their databases.


### 3.5 People management


### 3.6 Social work education

The work also includes supporting users and carers to become involved in social work education and promoting SCIE resources to students.




