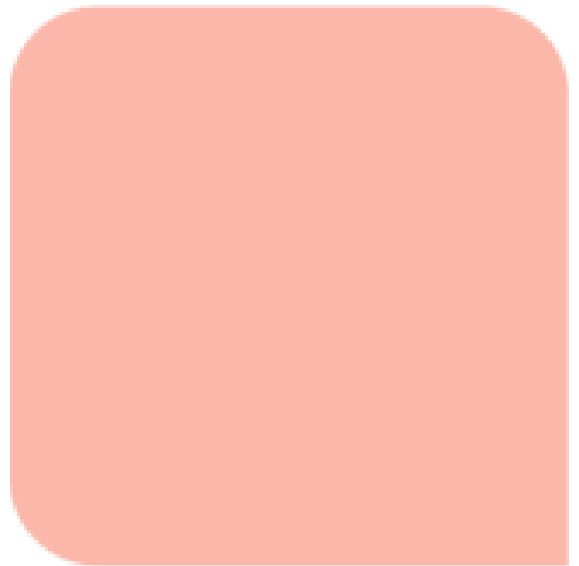


Report 22: Current social care information providers and their products, services, specialisms and intended audience

1 Introduction

The purpose of this report is to identify and map information provision within the sector in order to help users find their way round and see coverage at a glance.

The content of the report can also be used to identify gaps and overlaps in coverage between different social care information providers, and their subject specialisms.

2 Scope

The report focuses on the publishers of books, reports and audio/visual material that is included on Social Care Online (see [About Social Care Online](#) at www.scie-socialcareonline.org.uk for content selection criteria) and excludes journal publishers as these have already been researched.

Other parameters that were considered when deciding whether to include a publisher were as follows:

- the publisher must still exist as at August 2008
- the publisher must publish in similar formats to SCIE (e.g. books, reports, audio/visual resources)
- the publisher must have a regular publishing programme
- the publisher must be UK based

Everything on Social Care Online by publishers falling into the above parameters is included, except for audio/visual material, which has only been collected comprehensively since 2005. Social Care Online was established in 1986.

Social Care Online was established in 1986, as the library catalogue of the National Institute for Social Work. In 1994 the growing catalogue (which includes articles as well as books and reports) was made available on CD-Rom as Caredata CD. In the late 1990's Caredata became the Electronic Library for Social Care (ELSC) and when SCIE took it over in 2001 the Department of Health funded free access to the database on the Web. The ELSC became Social Care Online in 2005.

3 Method

A list was generated of all the publishers on Social Care Online.

A spreadsheet was created with the following headings:

- organisation (publisher) name
- organisation type (academic, commercial, government, NHS, private sector, voluntary sector)
- subject areas covered
- audience (practitioners, researchers, users and carers, all)
- publication formats produced by the publishers (book, mixed, report)
- publications included on Social Care Online (number of items by each publisher on Social Care Online)

Organisations that were easily identified as belonging in the organisation types (academic, commercial, government, NHS, private sector, voluntary sector) were added to the spreadsheet and data under the above headings.

A further trawl of the list of publishers was undertaken to make sure all key UK organisations with a publishing programme had been included.

Publications with the Social Care Online format 'audio/visual material' were treated separately because this type of material has only been collected if it falls into the core subject areas of the database, and has only been collected comprehensively since 2005.

4 Data

4.1 Publishers: books and reports

A wide range of different types of publisher, with different publishing programmes produce social care literature. These have been broken down into the following sectors:

- academic
- commercial
- government
- members organisation
- NHS
- private
- voluntary

These are shown in the graph in figure 1 below.

Using these categories, 140 publishers were added to the spreadsheet. Of these 72 were voluntary sector organisations, 27 were commercial publishers, 27 were government organisations (including arms length bodies), 8 were academic organisations, 3 were from the private sector, 2 were members organisations and 1 was NHS based.

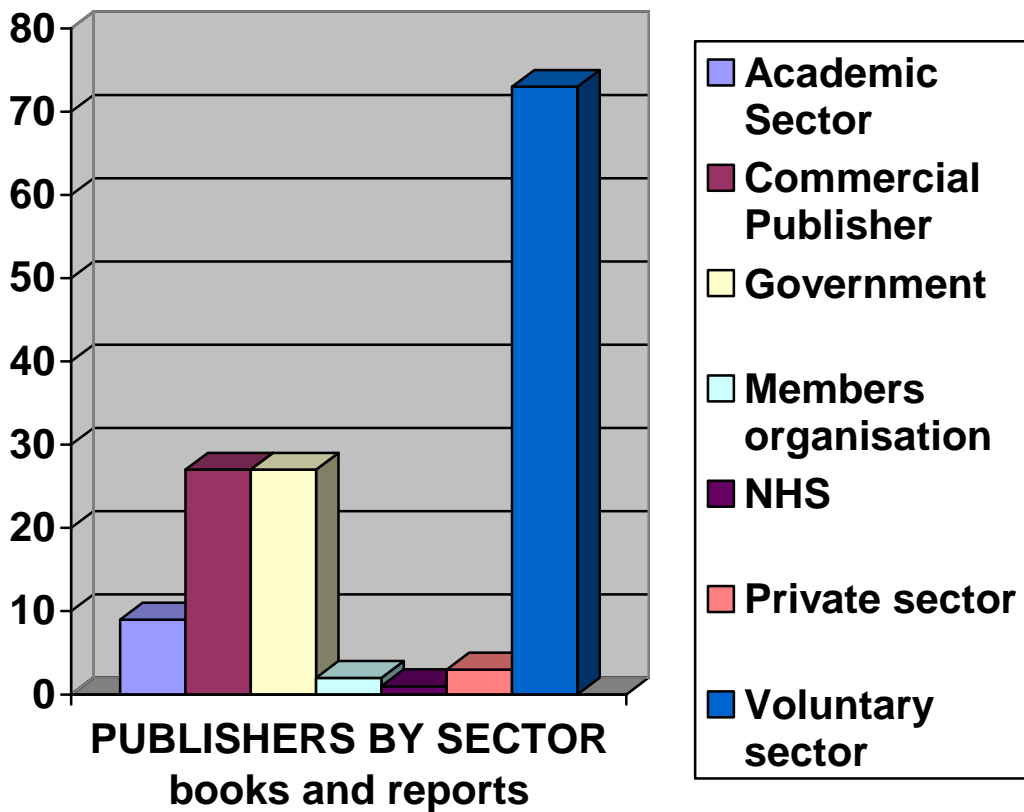

4.2 Publishers: audio visual material

At the time of this report, Social Care Online contains listings for 126 publishers of audio/visual material. However, 96 of these only has one item on the database and have therefore been left off of the chart in figure 2. Many of these will publish one off items to support a project or campaign, or have a publishing programme that covers a wide range of topics not relevant to social care. Of the 30 remaining, the voluntary sector is once again the most prolific publisher, followed by the commercial sector and the government.

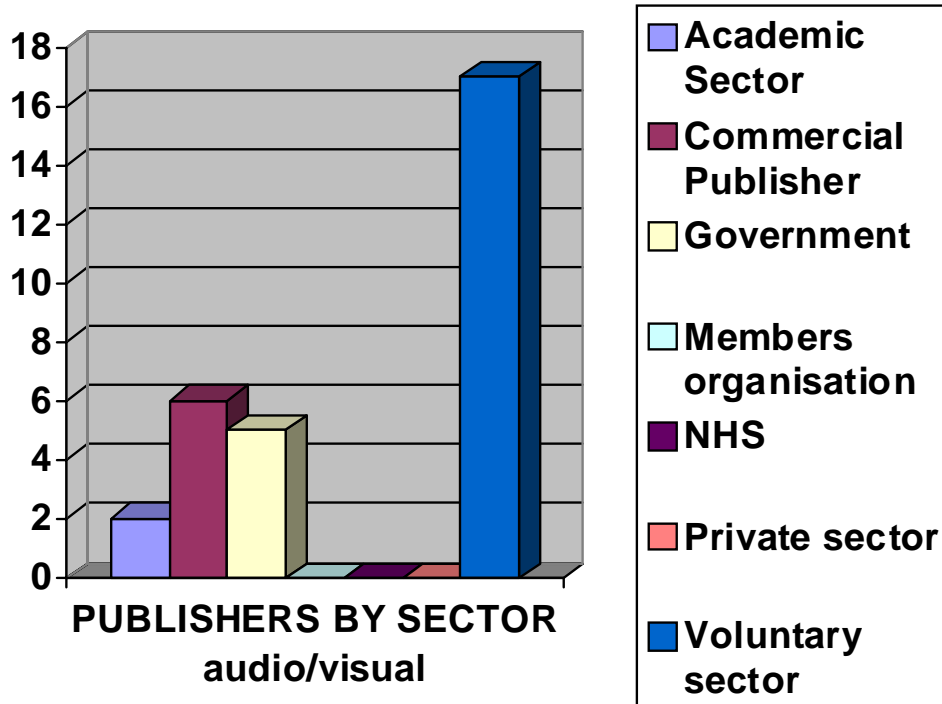

4.3 Audience: books and reports

The potential audience for social care literature includes practitioners, researchers, people who use services and their carers, students, and policy makers. Dividing the potential audiences into the broad categories: ‘all’, ‘practitioners’, ‘researchers’ and users and carers, 101 publishers aim their publications at a range of audiences and fall into the ‘all’ category, 130 aim them at practitioners, 78 at researchers, and 64 at people who use services and their carers (see figure 3).

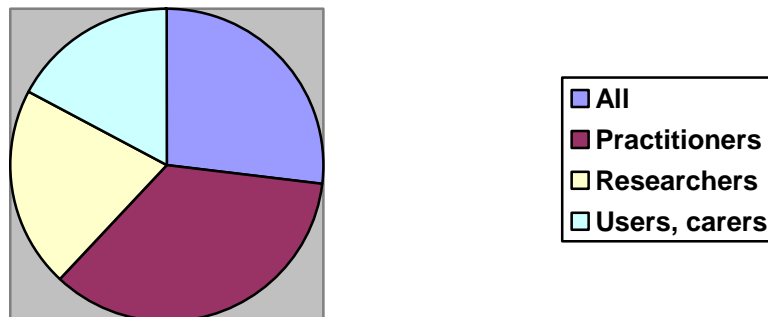

4.4 Audience: audio/visual material

An analysis of the audience for audio visual material suggests that more material is aimed at people who use services and their carers, and far less at researchers, with practitioners broadly the same in number.

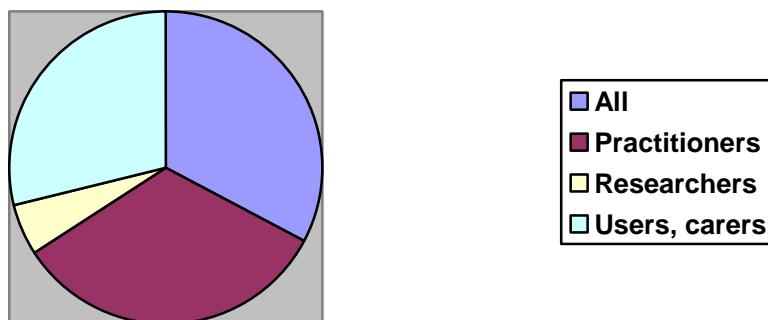

4.5 Publication format: books and reports

The most prevalent format for publications is the report (reflecting the number of voluntary sector and government organisations producing literature). These are often free and increasingly published on the web only. This is followed by books, generally published by commercial organisations, and usually priced and available only in paper format. Some organisations publish both books and reports and fall into the 'mixed' category in figure 5, below.

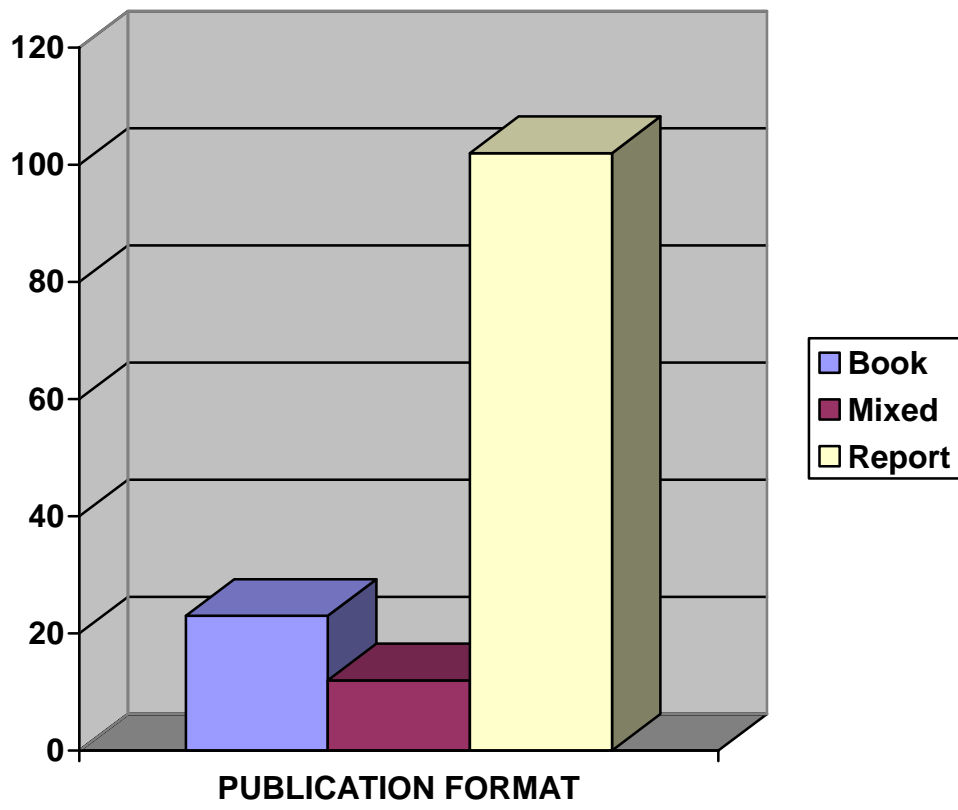

4.6 Subjects covered and who covers what: books and reports

Many organisations, particularly in the voluntary sector, focus on one subject area (e.g. Age Concern, Sainsbury Centre for Mental Health). Others, particularly in the commercial and government sectors, cover the whole of social care. These have been included under the broad heading 'social welfare' in figure 6, below.

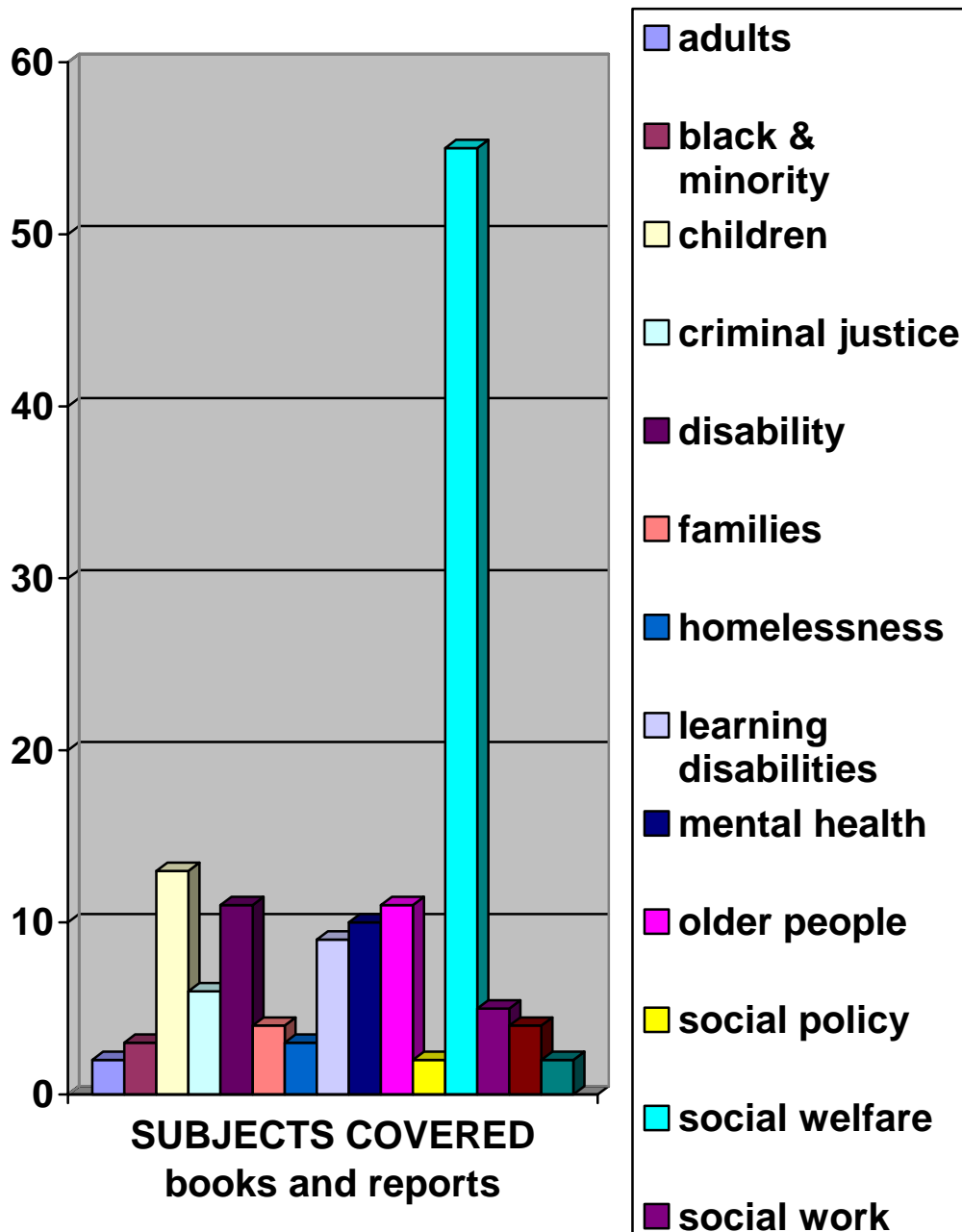

4.7 Subjects covered and who covers what: audio/visual material

There are fewer subjects covered by audio/visual material. Other than social welfare; children, learning disabilities and mental health score highest (see figure 7 below).

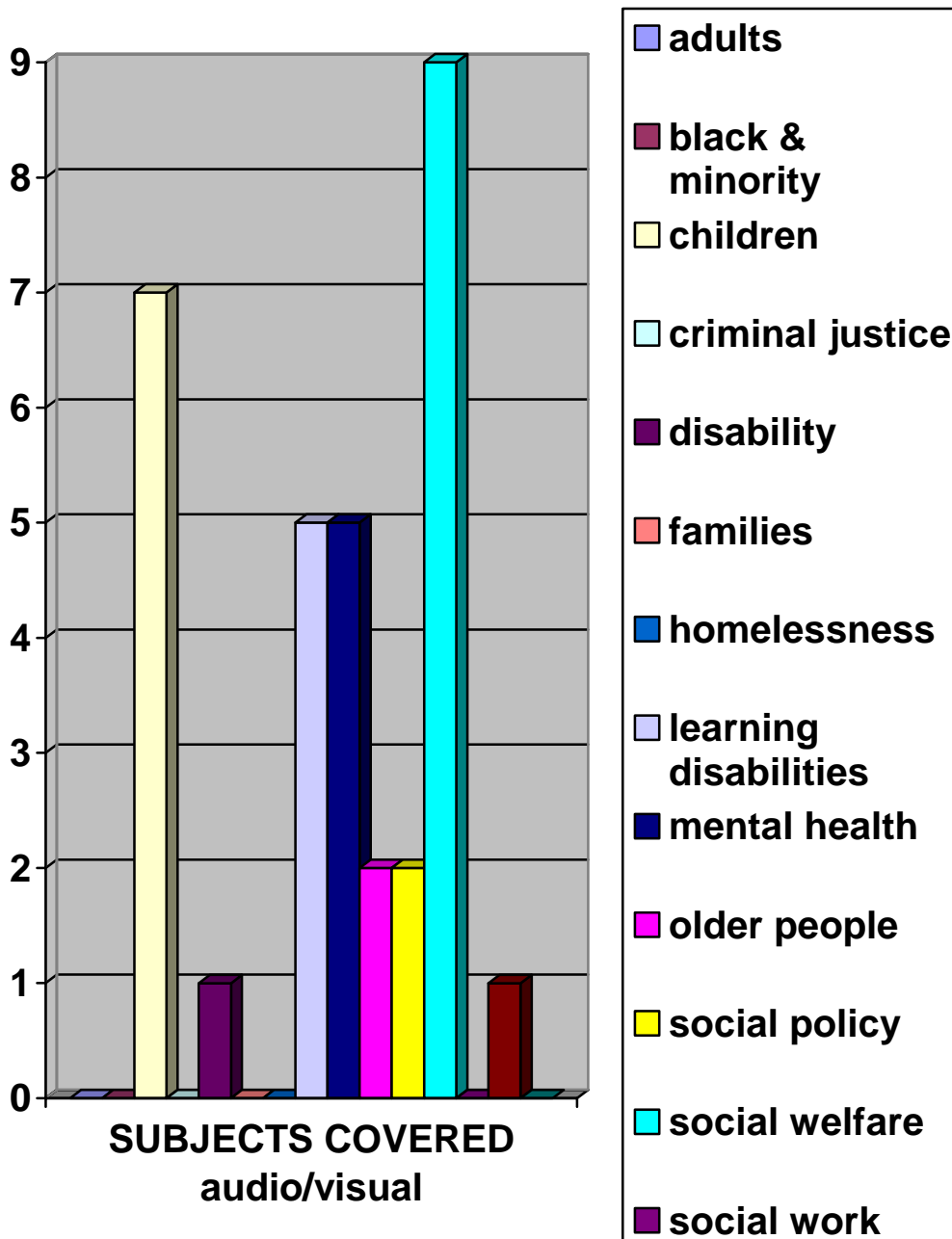

5 Conclusion

Social care publishing is increasingly prolific and the internet is contributing to this proliferation. Voluntary organisations with limited budgets are now able to publish easily and cheaply on the web. Government organisations and arms length bodies such as SCIE are doing the same, with an output of books and reports over the years equal to that of the commercial publishers. Seventy-three voluntary sector publishers are listed, more than double the number of commercial producers (27) or government publishers (27).

Almost all the organisations, even single subject ones such as Age Concern, BILD or the NSPCC have multi focused publishing programmes: they produce research publications, policy documents, practice guides, training packages, audio/visual material and user and carer focused information.

Many organisations cover a wide range of subject areas. Examples are commercial publishers such as Jessica Kingsley, Pavilion and Venture Press, and Government departments such as the Northern Ireland DHSSP or the Welsh Assembly Government, as well as organisations such as SCIE and the Audit Commission.

More organisations are producing audio visual material, including DVDs, e-learning packages, and video and audio and making these available via the web. NB this report has not covered the publishing outputs of local authorities, EU organisations, the United States and other countries, and journals publishers.

Information overload is coming from all sides in all formats, highlighting the importance of Social Care Online as a tool for finding carefully selected and indexed material in the desired format.

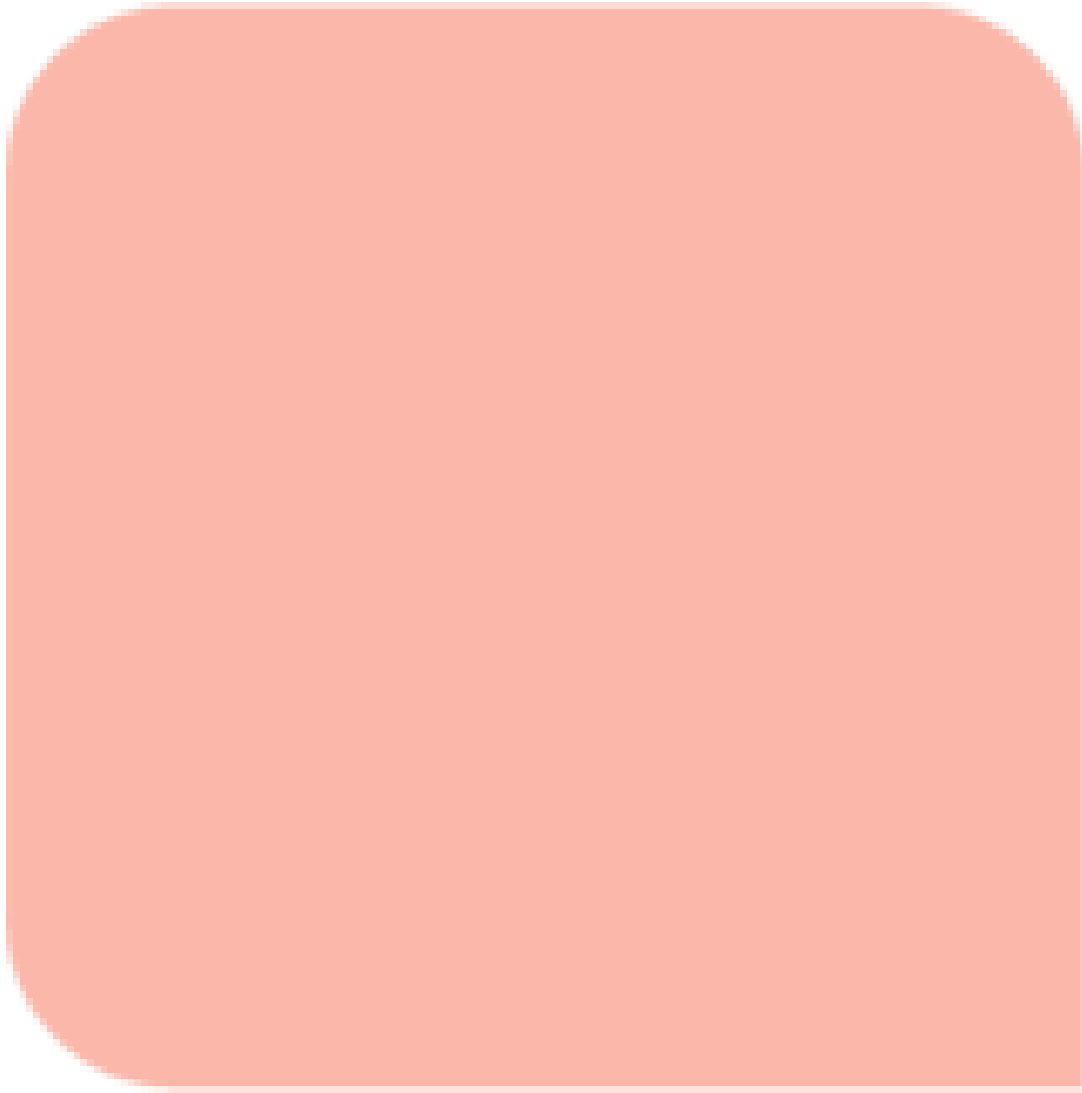
